Call To Order

Committee and Staff Reports

Given the confusion over RV regulations and staff's being responsible for implementing and enforcing the regulations, staff felt it was important to provide a staff-level interpretation of the issue. Staff has included in the packet, a comparative table to offer interpretation of the zoning regulations as they relate to RV parking and storage.

Public Hearing – City of Rose Hill Zoning Regulations
