During the past year, we have continued our work on our goals and projects for the community. COVID has been a challenge for this community and police department, and we implemented changes to keep the public as well as our officers safe during interactions. We have also stayed in tune with National events involving the law enforcement profession updating policies and attending required training. Community events were not held for most of the year however we are hoping that 2021 begins our road back to normalcy. A few highlights of 2020 have been:

- The City of Rose Hill, Kansas was designated by Safe-Wise as the 10th Safest City in the State of Kansas for 2020.
- Chief Mosley served as President for the Kansas Association of Chiefs of Police (KACP) during the term of 2020-2021.
- RHPD acquired PPE for the safety of officers and community members during contacts. Patrol tactics and responses to calls were adjusted to reduce potential COVID exposure.
- RHPD added Officer Peyton Heidebrecht to the roster. Additionally, Reserve Officer Daniel Harshbarger has started with RHPD as a Reserve and is progressing through our field training program.

I am proud to lead and serve alongside the dedicated men and women of the Rose Hill Police Department who are committed to maintaining Rose Hill as a safe and secure community. 



Reserve officers are volunteer, non-paid members of the department. They answer to the patrol lieutenant as their liaison in the Field Services Division. For 2020, Reserve Officer Harshbarger joined the unit and started his initial reserve officer training. He is currently in the FTO program with a slated completion time sometime in 2021.

Reserve officers go through the same hiring process that paid officers do for the Rose Hill Police Department. Their required initial training is 80 hours, and their field training is 220 hours. All reserve officers are required to maintain minimum standards for time worked as well as hours per year of training.

Depending upon our status with the COVID pandemic during the year 2021, the Department plans to initiate a recruiting campaign for RHPD Reserves to fill additional, available slots.

Rose Hill Emergency Services Chaplains Unit was created and exists for the sole purpose of partnering with, cooperating with, and assisting, Rose Hill Police Department, Rose Hill Fire Department, and other emergency services departments in our area, as requested, to assist in their service provided to the public. Providing counseling, emotional and/or spiritual support to citizens of the community as well as members of the various departments. Rose Hill Emergency Services Chaplains Unit is an independent volunteer organization of pastors serving Rose Hill and the surrounding area. There is currently four Rose Hill pastors serving the unit.

#### **Regular Meetings**

The RHES Chaplains meet bi-monthly on the first Thursday of the month. Meetings consist of lunch, planning, review of calls, sharing of information and training, as necessary. For 2020, the Chaplains only met in February and July due to COVID concerns.

#### **Call Activity**

The RHES Chaplains coverage area includes the City of Rose Hill and the Butler County Fire District #3. From time-to-time Chaplains help with the Butler County Chaplain Division that covers the entire county.

#### K-9 Unit, Patrol Deployments:

20-713 Open Door building, Rose Hill School District PD, K-9 assisted with building search, no criminal activity, door found to just be unlocked by employee.

#### K-9 Unit, Miscellaneous:

- October 2020 K-9 Unit recertified in the four odors of narcotics (marijuana, meth, heroin, cocaine) and evidence search. During this training K-9 Unit also certified, for the first time, in tracking, building search, area search, handler protections, and suspect apprehension.
- > K-9 Unit continues to train with outside agencies monthly as time and staffing allows.
- As capabilities grow the number of agencies and call outs received also grow. This year, even with Covid, there were a total of 13 deployments, assisting not only Rose Hill PD but also five other agencies.
- This list does not included deployments that K-9 was called off prior to arrival or request that were denied as they did not meet the requirements to call a K-9.
- Replaced the E-collar with new unit. Previous collar was approximately four years old and began having power issues.
- Approval to retro outfit existing police Explorer to K-9 Vehicle. K-9 Officer now has more room in the front of the vehicle, the K-9 still has separate space in the back, a new prisoner transport section, and space in the back-cargo area for all necessary supplies. With the

transition to the Explorer the K-9 also has a door popper which allows officer to hit a button and release the K-9 if the need arises.

- Through grant application K-9 received a bullet resistant vest, allowing for more protection on patrol deployments.
- As Covid continued to remain present through the year, the K-9 unit did not do any community events such as demonstrations or educational talks.

# **Operational Overview**

The Rose Hill Police Department serves the public 24/7 with law enforcement services. Major functions include, but are not limited to the following:

- Community Policing
- Criminal Investigations
- Traffic Accident Investigations
- Traffic Enforcement
- Emergency Preparedness, Planning and Response
- First Response (911) for Police, Medical and Fire calls
- Crime Prevention & Community Education
- Security for Municipal Court
- Animal Control

#### Criminal Investigations:

A full-time Detective serves the department through a variety of responsibilities. The responsibilities include but are not limited to investigating assigned felony, misdemeanor and child victim crimes, process crime scenes, fulfill the duties and responsibilities of evidence room custodian, serves as the department's Public Information Officer (PIO), serves as equipment room quartermaster, and oversees community events and crime prevention programs.

#### **Accident Investigations:**

Officers respond to, investigate and document traffic accidents within the city limits. The data is submitted electronically to the State of Kansas as required by statute. Public reports concerning the accidents are disseminated to insurance companies or other interested parties upon request for a fee.

#### **Traffic Enforcement:**

Traffic monitoring and enforcement of traffic laws is primarily designed to increase traffic safety. In accordance with that philosophy, officers structure enforcement times, locations, and offenses toward that goal. Although the number of fine generating citations written by Rose Hill Officers is below other comparable agencies by design, our traffic safety record is excellent. The number of state reportable accidents is low considering traffic counts place approximately 10,000 vehicles a day on Rose Hill Road.

#### Ticket or Treat Campaign

November 20 – November 29, 2020 27 traffic stops, 3 citations for speed, 2citation for other offenses

#### New Year's DUI Campaign

December 26, 2020 – January 3, 2021 19 Traffic stops, 4 citations for various offenses

#### **Emergency Preparedness, Planning and Response:**

Verbal agreements with four (4) church facilities provide storm shelters for community members in the event of a storm. Officers are tasked with unlocking the facilities upon receipt of a severe weather watch and locking the facilities back when it clears. The locations are:

- Rose Hill Christian Church, 314 N. Rose Hill Road. (Main door)
- Rose Hill First Baptist Church, 1206 N. Rose Hill Road. (Main door)
- Rose Hill Bible Church, Rosewood & Main. (Main door)
- United Methodist Day Care, Main & Showalter. (South door)

As storms approach, officers engage in spotting activities and coordinate our efforts with Fire District #3 and Butler County Emergency Management.

#### **Crime Prevention and Community Education:**

Although the Investigations Detective has the additional responsibility of overseeing community services, all officers are responsible for participating in community events and using community policing concepts and strategies. Some examples of events the department has organized or been involved with are:

- National Night Out 2020 Canceled Due to COVID.
- Hunter's Education Course 2020 Canceled Due to COVID.
- USD 394 Classroom talks on various topics 2020 Cancelled Due to COVID.
- Drug Take Back Program Conducted One Versus Two Drug Take Backs due to COVID.
- Tours of the Police Department 2020 Canceled Due to COVID.
- Crime Prevention and Safety Talks 2020 Canceled Due to COVID.
- Trunk or Treat Halloween, October 31, 2020.
- Movie in the Park 2020 Canceled Due to COVID.

#### **Animal Control:**

The department is responsible for animal control and the enforcement of the city code relating to animals. Animals that are picked up are taken to the Rose Hill Veterinary Clinic rather than housed at a city owned and maintained kennel.

#### Other Items:

The department continues work on the RHPD Policies and Procedures Manual by reviewing and updating existing policies. Many of the policies have been converted to a new format that provides better access to all members of the department since we have departed from the Lexipol Policy program that have increased pricing annually.

All officers are compliant with statutory requirements such as maintaining required training hours, firearms qualification, biased based policing training and reporting.

The use of the Criminal Justice Information System (CJIS) by the department requires certain policies relating to officer training, physical and remote access security as well as yearly criminal background investigations be conducted and complied with. The department is audited by the Kansas Highway Patrol for compliance. To date, we have successfully passed every audit. The next audit is scheduled for 2021.

The department transmits Kansas Incident Based Reporting and Arrest data to the Kansas Bureau of Investigation electronically through our records management system. All agencies are required to submit data per state law. Although our system is somewhat "bulky" with regards to transmission, we are compliant but are currently examining ways for a more efficient process.

In addition to transmitting criminal reporting data, we also collect and transmit fingerprints electronically. This capability not only provides almost real time confirmation of a suspect's identity (if their prints are already in the FBI system), but it allows us to meet the fingerprint requirements for background checks on officers per CJIS requirements. As a service to the public, we use this system to take fingerprints for employment purposes for a small fee. Fingerprinting services however was closed to the public from Mid-March through July 1, 2020. We also closed for a couple of weeks after Thanksgiving and Christmas to give time from holiday family gatherings. We are now fully opened back up through appointments only.

#### Municipal Court:

Although Municipal Court does not fall under the supervision of the Chief of Police, the court clerk as well as the records and reporting functions do.

During the year, court was closed in April and part of May due to COVID. Once, opened back up the number of people were limited in the court room and social distancing was imposed. Masks were mandatory and hand sanitizer was available for use. Temperature checks for each person entering were conducted as well. This procedure continued through the new year of 2021.












Annual Traffic Enforcement Comparison




**Annual Accident Comparison** 




**Annual Arrest Comparison** 









**Annual Residential Burglaries** 





#### Accomplishments for 2020

- > Officer Peyton Heidebrecht hired, September 21, 2020.
- > Reserve Officer Daniel Harshbarger joined the Reserves Unit, November 19, 2020.
- The department completed and passed annual Kansas Department of Health and Environment inspection of Intoxilyzer Equipment.
- > The Department purchased Tourniquets and carrying cases for all officers.
- City Council approved the update and purchasing of our Live Scan Fingerprinting Equipment. This update has improved our efficiency in fingerprinting citizens in a timely manner and allows electronic submissions of fingerprints to the KBI.
- The Department purchased a Jump Pack, an Air Compressor and Shop Vac Accessories for the department's fleet.
- The Department applied for and received a grant from Kansas Pipeline for LED Road Flares. Plug ins were installed in our patrol vehicles to keep these flares charged and ready to go.
- City Council approved the purchase of a new Dodge Durango as well as a conversion of the Ford Explorer to a K-9 vehicle.
- > The department purchased taser cartridges and taser batteries for our tasers.
- The department purchased an electronic Evidence wand and printer to catalog evidence electronically.
- The department received a ballistic vest grant in which the grant pays for 50% of the overall costs of the vest.
- > The department received the KDOT/AAA Award for a new radar system.
- > RHPD added our values of "Dedication-Integrity-Compassion" to all marked patrol vehicles.

#### Community Events 2020

- > The Spring 2020 Drug Take Back Event was canceled due to COVID concerns.
- > Movie in the Park was canceled due to COVID concerns.
- > National Night Out was canceled due to COVID concerns.
- > Rose Hill's Fall Festival was canceled due to COVID concerns.
- On March 6, 2020, RHPD sponsored a giveaway of a weather radio to a community member during Severe Weather week.
- On March 7, 2020, RHPD set up and conducted a booth at the Rose Hill Community Health Fair. We handed out valuable crime prevention information and freebies at the Rec Center.
- > Fall Drug Take Back, October 24<sup>th</sup>, 2020, 5 full boxes, weighing 101 pounds total!!

- November 21, 2020, Chief Mosley, and Detective Tharp assisted Louis Café in serving car side drive up Thanksgiving dinners sponsored by the Senior Center.
- 2020 Holiday Food & Toy Drive was quite different this year due to COVID. Collection sites were set up and donations were accepted without direct contact by RHPD members. This year our recipients were the Sunshine Children's Home and Families in our community. Officers also conducted traffic stops to hand out gift cards to spread Christmas Cheer versus citations. The event was a success.

#### Training for 2020

(All officers are required a minimum of 40 training hours annually to remain certified)

- During 2020 with the onset of COVID, most training for staff was kept to local in-house training and online training.
- > Detective Tharp attended the Kansas Police Administrator's Seminar, July 9-30, 2020.
- Detective Tharp Attended the 32<sup>nd</sup> Annual Virtual Crimes Against Children's Conference for a total of ten (10) Hours from August 10<sup>th</sup> through December 31, 2020.
- As a department, we utilized Virtual Academy more as a department to provide training to Officers to better equip them professionally to handle situations and protect themselves. Classes included bloodborne pathogens, criminal law classes dealing with 4<sup>th</sup> amendment issues, de-escalation for Law Enforcement and societal issues. We continued to do our mandatory classes including NCIC certifications, Intoxilyzer certifications and biased based police training.

#### Notable Cases/Projects 2020

- > On February 11, 2020 at 0440 hours officers on patrol observed a suspicious. When patrol officers got behind the vehicle and ran the license plate, they learned it had been stolen recently from a location in Wichita. A vehicle pursuit ensued which ended at the intersection of SW 120<sup>th</sup> St and SW Santa Fe Lake Rd after the suspect rammed a Butler County Sheriff's patrol vehicle. The suspect fled onto private property to the SE and into a heavily wooded area. Multiple agencies with the Rose Hill PD gave chase including Andover PD and the Butler County Sheriff's office. Several minutes into the foot pursuit, the suspect fired a single shot, and all law enforcement held the perimeter while a KHP aerial unit was requested. KHP air was requested and arrived on location a short time later and with the use of their FLIR the suspect was in a "shooting stance" appearing to lay in wait for responding units. After a perimeter which was held for over an hour the suspect gave up but complained of exposure due to his falling in water and the subfreezing temperatures. The suspect was taken to an area hospital where he was given care and it was learned he was lying about his name. While being transferred to the patrol vehicle from the ER the suspect managed to free himself and fled on foot, in a gown and in handcuffs. The suspect was again taken into custody by a Rose Hill Officer a short distance away while trying to enter someone's home. Due to the efforts of our Officers and the aid of surrounding agencies, this person's crimes were identified and/or stopped and he is currently incarcerated in the Department of Corrections.
- Officer Lee was involved in a vehicle pursuit after noticing the vehicle speeding on Rose Hill Road. The pursuit ended in Andover with the assistance of Andover PD. Officers arrested 3 juveniles from the vehicle involved. The vehicle had been stolen from a person in Wichita earlier that week when the suspects forced the owner into the trunk. They would later release the victim without harm but kept his vehicle. Wichita Police took custody of the driver in connection with their case and the other two passengers were released to parents.
- On July 4, 2020 at 2358 hours, officers responded to an address in the Sienna Ranch neighborhood to take the report of a missing person. Upon arrival we learned the person missing was a 22-year-old female who reportedly had a "delayed mental capacity" and

numerous medical concerns. The caller was found to be the mother of the person missing and both were from Texas and just got to town to visit family. Due to the totality of the circumstances additional help was requested and soon, additional officers arrived as well as Fire Department personnel. A reverse 911 was sent out to the area to inform residents and canines with tracking ability were acquired through the Fire Department. The missing person was located at approximately 0300 hours, in a tree which was along a wooded path but otherwise not harmed. Through mutual efforts of local agencies and a refusal to quit, the missing person was returned to her family and soon thereafter transported by them to an area hospital for evaluation.

- Rose Hill Police Department worked three suicide cases for the year. One suicide by gunshot occurred with Chief Mosley and Lt. Parlier in the residence at the time they were checking the welfare of that individual from a dispatched call. Another case was an attempt where the individual was not pronounced deceased at the time but would later die later at the hospital.
- August 12, 2020, Lt. Parlier took the report of a stolen trailer. A short time later, it was reported that the trailer was being sold in Wichita through Facebook marketplace. Lt. Parlier and Det. Tharp intercepted the sale and recovered the trailer at a Dillon's Marketplace in Wichita. The suspect was arrested and transported to the Butler County Jail. RHPD's work in the investigation led to the suspect being placed on electronic monitoring. Other agencies were able to tie some of their cases to this suspect, resulting in numerous court appearances for the suspect, ultimately leading to him being incarcerated with a \$135,000 bond in the Butler County Jail. Information was shared on KIA (a group that shares information for identification of suspects, sharing case information, theft and drug trends, officer safety, etc.) Outstanding work!
- The department worked burglary cases to Louis Café and Midtown Auto. Another burglary also occurred at the barber shop on a separate date that we believe is connected to the other cases. A fingerprint was secured from a damaged vehicle which was initially thought connected but evidence did not substantiate. Fingerprint had no comparison in AFIS. Investigation brought in Coin star and area banks to isolate a lead as coins were a major portion of the theft. Investigation on-going with persons of interest identified.

#### RHPD Awards 2020

- Aubry Dieter of Emprise Bank was recognized by the department with a plaque for preventing financial crimes against a customer at Emprise Bank (Sept 2020).
- Belal Seyam, was recognized with a department plaque for assisting in the apprehension of a violent offender, risking his life and personal injury, February 11, 2020.
- February 27, 2020, Officers Weekley and Sibley were recognized with Life Save Awards at the 2<sup>nd</sup> annual Cardiac Arrest Survivors Banquet.
- Officer Sibley received a commendatory performance report for assisting a citizen by returning a lost her wallet.

#### Miscellaneous 2020

- > Christian group visited on July 23, 2020 to pray for the city and our officers.
- Death of Jim Schmidt, long time Director of Butler County Emergency Management, 25year FD#3 firefighter, community member, April 14, 2020, RHPD participated in the parade of emergency vehicles for a food drive drop off in Wichita, in the memory of Jim.
- In March 2020, Chief Mosley spoke to the 7<sup>th</sup> Grade Class about tips in preparing for a career.
- Officers spent more time checking on mental health and possible suicidal people than in recent years, which could be a result of how society and individuals are handing COVID 19.

#### Goals for 2021

RHPD will attempt to apply for and hopefully receive grant funding for two new commissioned positions. With the type of cases, we are seeing now that would typically

require a two-officer response, we need to update the department number of staff for safety and scheduling coverage purposes.

- The department plans to send a department member to be trained and certified as an armorer for our various weapon platforms.
- Continue to work towards the goal of every member receiving CIT (Crisis Intervention Training) as training sessions are available and scheduling permits.
- Schedule a department member to get certified as a defensive tactics instructor to be able to train members on a regular basis. Officer Lee will be the likely candidate to serve.
- Complete the revision and update of the Department's Policies and Procedures.
- Finish repairs on the shooting lanes at the department range and create training, over and above annual qualification.
- The department plans to work towards more DUI training including ARIDE and work toward having a DRE (Drug Recognition Expert) on staff.




